



Costa Rica Aggressive Business, Tax & Practice Management March 27 – April 2, 2016

Please note that the itinerary below is not an exact representation of the final program. The time, order, location, and content of the professional meetings are subject to availability of and confirmation by the hosts, as well as the relevant background and expertise of the traveling participants.

Sunday, March 27th, 2016

Arrive at Juan Santamaría International airport (SJO) in San José, Costa Rica. Upon arrival, you will be welcomed by an expert guide and transferred to Herradura Beach, located about an hour and a half from San José. After checking in to the *Marriott Los Sueños Ocean and Golf Resort*, and taking some time to settle in, enjoy a group welcome dinner at the resort.

Monday, March 28th, 2016

The meetings room is reserved for half-day, it can be used during the morning or afternoon. The meeting room use includes audio and video equipment, set-up as you prefer and coffee-break.

Afterwards, you can relax at the resort’s spa, play a round of golf or enjoy the nearby beach. Optional excursions will also be made available. A sampling of excursions offered are listed below:

- **Horseback Riding and Waterfalls tour-** Depart from the beach by horseback to an 80-acre private rainforest property with a naturalist. Along the way, spot some of Costa Rica’s famous wildlife, including Toucans, Scarlet Macaws and White-faced monkeys. Afterwards, enjoy a swim at a natural pool with waterfalls.
- **Zip Line Canopy Tour:** Depart the resort for a 15 minute ride up to the top of the mountain. After a safety briefing, descend to the bottom via a series of zip line cables. You will cover a total distance of 3.5 kilometers through the rainforest, with an opportunity to view the local wildlife.
- **Carara National Park Hike:** A must for wildlife enthusiasts! Enjoy a 2 mile guided hike viewing the plant and animal life of the park. The park is home to half of Costa Rica’s avian species. At the conclusion of your excursion, cross the Tárcoles River, known for its huge population of crocodiles. From the safety of an overhead bridge, view the river’s inhabitants from above.

Thursday, March 31st, 2016

Travel north to the Arenal Volcano National Park. Arrive in the early afternoon and check into the Arenal Kioro Hotel or the Royal Corin, both located right outside of the park and known for their beautiful views of the volcano. The afternoon is free to explore the grounds, or to take advantage of the hotels’ hot springs. Transportation will be provided for those who would like to visit La Fortuna village.

Friday, April 1st, 2016

In the morning we will take the Group to the Arenal Volcano National Park for a Guided walk.

The Arenal Volcano tour starts with a drive to the western side of the volcano, which offers the best view because of an active vent. Once there, you will embark on a hike with a park ranger who will talk about the variety of plant and wildlife.

Once on the top of the lava flow you will have a beautiful view of Arenal Lake. The hike ends up at a view point. If the weather cooperates, you will have a breathtaking close up view of the volcano.

The afternoon is free to relax at the hotel or for optional activities (list of activities forthcoming)

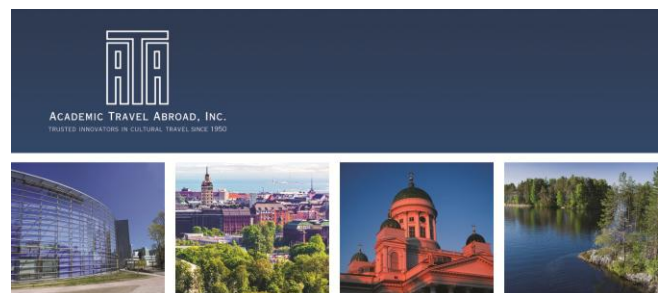
Saturday, April 2nd, 2016
